Your ocean beaches are under attack. Lack of protections is allowing inappropriate land uses that could take away your ability to enjoy a walk on the beach or the excitement of digging for razor clams. Lack of protections is impacting critical habitat for a variety of wildlife, birds, fish and other marine organisms.

It's your beach. But what if there was no sand, restricted access and no clean water? What if the miles of public open ocean Washington beaches erode into cement boardwalks holding up miles of private condominiums? The development will have significant impact on two of Washington's most popular day parks, access to prime razor clamming opportunities and legendary surfing.
